Mi, e levél aláírói – akiknek alkalmunk volt a Lukács Archívumban dolgozni, vagy kutatásaink során élveztük az Archívum segítségét és támogatását; akik hozzáférhettünk az ott őrzött nyomtatott és kéziratos anyagokhoz, és akiknek elkerülhetetlenül szükségünk van a jövőben is erre; vagy akik nagyra tartjuk azoknak a tudósoknak a munkáját, akiknek lehetőségük volt az Archívummal kapcsolatban állni –, döbbenet értesültünk arról, hogy minden előzetes ígéret és bizonykodás ellenére az MTA Könyvtár és Információs Központ a kéziratok elszállításának előkészületein munkálkodik. We the undersigned, who have had the opportunity to work at the Lukács Archive and/or enjoy the support and help of the Archive during our research, and for whom access to the printed and written manuscripts held at the Archive will continue to be an ineluctable necessity in our future work, were appalled to learn that despite the earlier promises and reassurances, the Library of the MTA is preparing to remove the manuscripts from the Lukács Archive. Such a step would destroy the independent character of the Lukács Archive—which should also be important for the MTA to maintain—and would cause inestimable damage to research. This is why we ask those responsible for the MTA and the Library of the MTA to stop this plan, in the interests of research.
